NOW, THEREFORE, IT IS HEREBY ORDERED that Plaintiffs' Motion is GRANTED.

The Class Action Settlement between Plaintiffs Jeremy Raymo, Forrest Poulson, Gary Gaster, Brendon Goldstein, Manuel Pena, John Reyes, Dennis Kogler, Clarence "Todd" Johnson, Stephen Zimmerer, Justin Sylva, Ian Hacker, Jason Gindele, James Blount, Luke Wyatt, Chris Wendel, Darin Ginther, and Matt Baffunno (collectively, "Plaintiffs") and Defendants Cummins Inc. and FCA US LLC is preliminarily approved.

- 2. The proposed Settlement Class is preliminarily certified, for settlement purposes only.
- 3. The firms of Hagens Berman Sobol Shapiro LLP, Carella, Byrne, Cecchi, Brody & Agnello, P.C., Seeger Weiss LLP, and The Miller Law Firm, P.C. are appointed as Class Counsel.
- 4. The form and content of, and distribution of, the proposed Class Notice is hereby approved, and the Settlement Parties are hereby authorized to retain JND Legal Administration as Settlement Administrator.
- 5. The following schedule sets forth the deadlines related to the Notice required by this Order, Class Counsel's application for costs, fees, and incentive awards, and Class Members' rights to object or opt out of the Settlement:
