1 Pursuant to L.R. 160, Plaintiff RBB2, LLC and Defendant CSC ServiceWorks, Inc.
2 (“CSC”), by and through their undersigned counsel, hereby notify the Court that a proposed
3 Class Action Settlement (the “Settlement”) has been reached that will, if finally approved,
4 resolve this matter in its entirety. The signatories to the Settlement have sought preliminary
5 approval in the Circuit Court of Cook County, Illinois—where another case against CSC was in
6 progress. A copy of the Motion for Preliminary Approval and supporting documents are attached
